## 1. TOURNAMENT BACKGROUND

The PTBS Invitational Tennis Classic (PITC) 2026 (3<sup>RD</sup> Edition) is jointly organized by **Persatuan Tenis Bumiputera Sarawak (PTBS)** and **TF Rinduk**.

The Primary Objective of the Tournament is to promote Tennis and Sports Tourism (Sarawak's warm hospitality, diversity, and unity) in Sarawak. It is also organized in memory of the late President of Persatuan Tenis Bumiputera Sarawak (PTBS), Y Bhg Tan Sri Datuk Amar Haji Bujang Mohd. Nor, who was instrumental in promoting Tennis in Sarawak in the 1970s, 80s, 90s and 2000s.

## 2. TOURNAMENT DATES

Tournament starts Thursday 6<sup>th</sup> August to Sunday 9<sup>th</sup> August, 2026 commencing at 1400hrs onwards.

## **6. CLOSING DATE OF ENTRY**

6.1 Entries must be received by **MONDAY 13<sup>th</sup> July, 2026 at 1700hrs Malaysian Time**

6.2 ***LATE ENTRIES OR ENTRIES WITHOUT CONFIRMATION OF PAYMENT WILL NOT BE ENTERTAINED***

6.3 **NO REFUND** shall be made after the above Payment has been made.

6.4 As this Tournament is limited to **SIXTEEN (16) TEAMS**, please make sure your participation in this Tournament has been confirmed by the Organizers before making prior arrangements.

## **7. TOURNAMENT FORMAT**

### **7.1 TEAM EVENT (Group & Knock-out System)**

7.2 Minimum Eight (8) Players, Maximum Ten (10) Players **(Team Manager included)**

7.2 Player's Age shall be based on **Year of Birth**.

7.4 Open to all **Malaysian** and **Non-Malaysian**.

7.5 Each Player can play in the Category **STRICTLY** according to his **Age Eligibility**. Each Player is **ONLY** allowed to play One (1) Match in Each Tie.

7.6 Limited to **SIXTEEN (16) TEAMS ONLY** – Four (4) Groups of Four (4) Teams Round Robin with Top Two (2) to the Quarter – Finals (Knock-Out Format).

7.7 Points System - Win – 3 Pts - Draw -1 Pts - Lost – 0 Pts.

7.8 In the event of Two (2) Teams obtained the same Points and Score, it will be decided by Ladies Doubles won between the Two (2) Teams.

7.9 Teams in the 3<sup>rd</sup> and 4<sup>th</sup> Placing in each Group will play in the **LOSER'S POOL** (Knock-out Format).

7.10 All Group, Quarterfinals and Loser's Pool Matches will be based on:-

7.10.1 Game Pro-set. Normal Tie Break at 8-8 (7 Points). No Add Scoring.

**\*Two (2) Balls per Match**

7.11 Winner Pool Semi-Finals and Final Matches will be based on:-

7.11.1 Two (2) Tie Break Sets & Final Set – Based of 10 Points Match Tie Break. No Add Scoring.

**\*Three (3) Balls per Match**

7.12 **Fifteen (15) Minutes Walkover** will be strictly observed after Official Announcement of commencement of each match

7.13 Team Event is scheduled to start at **1430hrs – Thursday, 6<sup>th</sup> August 2026.**

7.14 Any changes to the Team Registration can be made during the Team Manager's Meeting.

7.15 No changes of Players are allowed after the Line-up Form has been submitted to the Tournament Referee (TR).

7.16 To ensure observance of gentlemanly conduct during the tie, "out ball or line call" will be based on Receiver's Call.

7.17 In case of incremental weather, the Tournament Referee (TR) and Organizing Committee reserve the right to change the Format/Scoring System and may reschedule matches in order to complete the Tournament for both events.

## **8. NON COMPLIANCE**

8.1 Any Non-Compliance of Age Eligibility registered in the Nomination Form which has been submitted and announced by the Tournament Referee (TR), the said Tie will be defaulted.

8.2 If the same Non-Compliance is committed by the same Team, all the Matches shall be defaulted and the Opponent shall be declared the Winner by the score of 4-0.

## **9. OFFICIAL BALL**

9.1 **Dunlop Australian Open (AO) Ball** will be the Official Ball. In case of unforeseen circumstances, the Organizer reserves the right to use other ball.

## **10. TEAM MANGER'S MEETING**

10.1 **Thursday, 6<sup>th</sup> August 2026 @ 0830hrs** at Persatuan Tennis Bumiputera Sarawak (PTBS). **Only Team Manager or Captain** is invited for the Meeting.

## 11. ACCOMODATION AND TRANSPORTATION

11.1 Each Team is responsible to provide transportation for their players to the respective Tennis Courts during the Tournament.

12.1 All participating teams and it's delegated Tennis Players/Officials **MUST** agree to indemnity and hold the Organizers, Persatuan Tennis Bumiputera Sarawak (PTBS), Kelab Permain Tennis Rinduk (TF Rinduk) and Kelab Golf Sarawak (KGS) free and unaccountable for and against any claims arising from personal injury, death, or property damage, arising out of or in any way resulting from the participation in the said Tournament.

## 13. PERSONAL BELONGINGS

13.1 It is the Tennis Player's responsibility to keep their own belongings safe and close by while at the Tournament Venues. Please **DO NOT** leaves any personal belongings, tennis bags etc unattended at any time. The Organizers will not be liable or held responsible for any loss, theft, or damage to your personal belongings.

## 16. DISPUTES / COMPLAINTS / RESOLUTIONS

16.1 In the interest of the smooth running of the competition, **ONLY** the Team Managers are allowed to file any complaint (s) or dispute (s) to the Disciplinary Committee.

16.2 A Non-Refundable Deposit of **Ringgit Malaysia Five Hundred (RM500.00)** is required together with the written complaint (s) or dispute (s).

16.3 Any decision by the Organizing Committee on the dispute shall be **FINAL**.

## 17. RULES & REGULATIONS

17.1 The Rules & Regulations for this tournament shall be based on **International Tennis Federation (ITF) and By-Laws of Lawn Tennis Association Malaysia (LTAM)**.

## 19. NOTICE OF EVENT POSTPONEMENT & CANCELLATION

19.1 The Organizers have the right to cancel or postpone the Tournament under specified conditions; entry fees shall be refunded accordingly

19.2 In the event that the Tournament is suddenly postponed and declared ***force majeure*** at short notice by the government due to unforeseen circumstances related to natural disasters, riots, outbreak of diseases, fire or any event deemed by government authority as a risk to public interest and safety, the Organizers will observe the instruction to postpone or cancel the event without prejudice to any legal action that the participants may wish to take against the organizers e.g. claim for damage, loss, distress etc. Under such circumstances the participants agree that they will not hold the Organizers accountable for any form of loss caused to the teams registered for the event.

## 20. ALCOHOL / DRUGS / TOBACCO

20.1 Tennis Players registered to compete in this Tournament are strictly prohibited from consuming alcohol at PTBS, indulging in substance abuse, or smoking while participating. Any Tennis Player found to have breached this requirement is deemed to have broken the universal tournament ethos and can endanger the smooth running of the event, mar the reputation of the hosts, and endanger the safety of other Tennis Players and the Public at large. For such breach of sports ethics, the Organizers reserve the right to eject the affected Player and prohibit the offender from further participation in the Tournament. The Team he/she represents may be subject to further action as deemed fit by the Organizers.

20.2 While no alcohol and smoking restrictions apply to general spectators who are not participants in the Tournament, substance abuse is strictly prohibited.
